ANNUAL REPORT AND ACCOUNTS FOR THE YEAR 2007-08

Dear Member

We take pleasure in presenting the Annual Report and Audited Accounts of the Bhubaneswar Club Ltd., for the year 2007-08. Our Club continued to maintain best standards of its services to the members in keeping with its reputation as one of the few sought-after clubs in the country.

This year we begin the Annual report with the achievements, improvements and additional facilities made available to our esteemed members instead of beginning with the drab figures. Please kindly note that the figures are also very much presentable and attractive.

2. Club's Cuisine and Bar /Beverage Services

The Indian Dinning Hall which had been renovated and refurbished with the sponsorship of Pine Cask has been a main attraction for members and their families. The year too the Club's Indian cuisine has been very popular. The Chinese Dinning Hall has also been renovated by the UB Group (Antiquity) and also been in demand among the members and their families. Both the dining halls always remain full particularly in the evenings.

2. GYM

The GYM was inaugurated by Sri Kalyan Coomar Jena, Chairman Railway Board, the first officer from Orissa to have reached such a height in Indian Railways. The GYM has equipments and work stations of TECHNO GYM an Italian manufacturer who is official supplier to the forthcoming Beijing Olympics in China. The GYM was partially sponsored by a number of leading Industrial Houses of India. There is a newly made Jacuzzi next to the swimming pool. There are two steam Chambers inside the Gym building for steam bath. Our Club has appointed trainers for the GYM. The GYM centre too has become an attraction for members and is a new feather in the CAP of our Club.

3. Lounge and other Additions

A new lounge has been added with a wall mounted Plasma TV. A new Conference hall is nearing completion and the Reception area and one of the corridors are being given face lift. The entire project has been sponsored by M/s Pine Cask.

4. Replacement of Lift

The old lift has been replaced with a new OTIS lift which now connects the Teesri Manzil. The lift is Technologically advanced and the same can be compared with lifts at any five star hotel.

5. Additional facilities

The two clay tennis courts have been re-laid by the Khurda District Tennis Association and the Club facilitated in organising a State level Tennis tournament.

The poolside bar has been adopted by M/s.UB Spirits along with the Swimming pool. The toilets at the swimming pool have been renovated and an wash stand has been provided.

An additional transformer of 250 KVA capacity has been installed to take care of the increased power load.

The Club has brought out a new Members Directory which is self funded and is printed in colour.

The garbage outlet has been expanded.

6. Country Club land

The Club had approached the G.A.Dept to allot a plot in exchange of the land allotted earlier at Chandrasheekarpur as the same was used earlier as dumping ground for municipal garbage and was not conducive for Club use. The G.A.Dept has allotted a plot of 5 Ac. at Ghatikia adjacent to SUM Hospital with a 100 foot wide road on two sides and also existing boundary walls on two sides. The proposed project would have a tennis academy with eight courts. There would be indoor Badminton & Squash courts as well as a bowling alley. The Building would have double basement, parking facilities and state of the art Club facilities including similar facilities existing in the present club premises. **The Project cost has been estimated at Rs.16.50 crores in the first phase only for civil construction.**

7. Entertainment Programmes, Cultural Functions and Special Events

Your Club has established its credentials as a very eventful entertainer for family members.

The Annual General Meeting was held on the 14th of July 2007 and the same was followed with Housie for ladies followed by Lunch. The 61st Pre-Independence Nite was celebrated as usual with patriotic songs.

The Club's annual Disco Dandia nite was the first event during the Festival season of Durga Puja. The Club celebrated with Light music and fireworks on the Pre Diwali evening and all these events were graced by our members accompanied with their families.

The Children participated in the Children's Sports and annual Boogie Woogie followed by prize distribution. The Pre Christmas was well attended with a magic show which was the main attraction of the evening for children.

The New Year's Eve was celebrated with great fun and fanfare and the members danced their way welcoming the New Year with colourful fireworks and the backdrop for the year was a replica elegant remnants of the famous Buddhist complex at Lalitgiri and Ratnagiri.

The Pre Republic day evening was also celebrated in gaiety and patriotic songs.

The Club picnic was held at the Samantray Farm House at Pratapnagari which was attended by members. The annual Volley ball tournament in memory of Late Izhar and Hooda (employees) was held. The inter club Late Gora Das Memorial Cricket was held at Barabati Stadium under the Arc Lights where our club won the match against Cuttack Club. The evening ended with a musical nite and dinner at the pool side of Cuttack Club.

The Pre-Utkal Divas Celebration was held on 31.03.2008. This year we had a backdrop of a typical ethnic village. At the musical evening many a famous singers presented songs including the songs of Late Sri Akshaya Mohanty. As usual the members had the taste of the Thella Gadi Gupchup, Dahibara / Aloo dum, Chat, etc.

The Annual rain dance was held on 7th June 2008 with the sponsorship of M/s Pine Cask.

8. **Games & Sports**

As in the past year the Tennis, Billiards, Snooker continued to be popular. Tennis has become "round the year" sport for the enthusiast members and the Club has engaged a coach to render training for young tennis aspirants.

9. **Swimming Pool**

The Swimming Pool which was redone under the sponsorship of UB Group of Companies (White Mischief) has gained more popularity and this summer the demand for coaching had increased.

10. **Library, Lounge, Beauty Salon and Lawns**

The year began with a number of books being donated to the Club by members. In the age of internet the Limited Library facilities which are provided in the Lounge was in demand by elderly members. Newspapers and periodicals are regularly being subscribed and made available in the Lounge for members' use. The Salon services are provided for gentlemen with specified timings. The lush green lawns continued to be the pride of the Club.

11. **Communication Centre**

The Communication Centre continued to render excellent services to the members as well as the visiting members of other clubs with STD/ ISD Local, Facsimile, Internet E-mail and DTP facilities.

15. **Personal Accident Insurance Cover for eligible members and staff**

REVENUE SURPLUS ACCOUNTS

Kitchen sales topped all-time high at Rs.150.59 lakhs, and registered an increase by Rs.13.98 lakhs over last year. Kitchen surplus after staff salary and expenses stood at Rs.15.44 lakhs. The rate of return stood at 10%. The kitchen has shown improvement, However, in spite of increase in input cost there was no corresponding increase in billing amount of kitchen. The Club absorbed the market price increases and did not pass on the price escalation in purchases to the members.

Bar sales have marginally increased from Rs.83.01 lakhs (last year) to Rs.98.05 lakhs during the year.
Bar surplus stood at Rs.22.07 lakhs.

Guest Rooms surplus stood at Rs.23.53 lakhs.

DEFICIT NET REVENUE ACCOUNTS

The Deficit Revenue Account comprises Billiards, Entertainment Programmes A/c. Other Games A/c. and the Swimming Pool A/c.

This year also we have been able to present a good number of Entertainment programmes. However, this year we have been able to reduce the deficit on this a/c. to Rs. 0.61lakhs as compared to Rs. 8.09 lakhs to previous year. A shortfall in the Swimming Pool A/c. has emerged due to charging of salaries of staff attached to the Swimming Pool. Otherwise, the receipts and expenses (other than staff salaries) under Swimming Pool compared reasonably well with that of previous year.

23. Tax Demand Issues

(i) Income Tax

a. The demand raised by the Income Tax Department on completion of Assessment for the Assessment Year 1997-98 has been adjudicated in favour of the club by the Hon'ble Income Tax Appellate Tribunal, Cuttack.

b. For the assessment years 1999-2000 to 2003-2004 tax demand of Rs. 2.69 crores has been raised. The 1st appeal was disposed of partially in favour of the Club resulting in reduction of the demand to Rs. 39,34,131/- only. The Club has preferred 2nd appeals before the Hon'ble Income Tax Appellate Tribunal against the 1st appeal orders.

(ii) Service Tax:

The Club has also preferred an appeal against the notices of Service Tax Authority before the Hon'ble Orissa High Court.

(iii) Sales Tax:

The Commercial Tax Authorities had noticed the Club under the OST Act for assessment for the financial years 2000-01 to 2004-05 and had also assessed the club raising a demand of Rs. 2.68 crores. The Assessment has been challenged before Hon'ble Orissa High Court and as per directions of the Hon'ble Court a sum of Rs. 33.50 lakhs has been deposited with the Commercial Tax Department. Further appeals against the orders of the the 1st appellate authorities has been preferred before the Hon'ble Commercial Tax Appellate Tribunal which are pending.

(iv) VAT:

A demand was raised up to December 2005 by assessing a sum of Rs.2.00 cores. The club had filed writ before the Hon'ble Orissa High Court wherein the Club had challenged the basic issues about mutuality. The Hon'ble Orissa High Court had granted stay on demand and as per order of the Hon'ble High Court, Club has deposited a sum of Rs.7.00 lakhs with the Commercial Tax Authorities. The order of the 1st appellate authority has been preferred by the Club before the Hon'ble Commercial Tax Appellate Tribunal which is pending

Sufficient care has been taken for the maintenance of adequate accounting records in accordance with the provisions of the Companies Act, 1956 for safeguarding the assets of the Club and for preventing and detecting fraud and other irregularities. The annual accounts have been prepared on a going concern basis.

25. **Conservation of energy, Technology Absorption and Foreign Exchange Earnings and Outgoings**

The Club, being a mutual concern involved with social, cultural and sports activities of members, has not consumed energy of any significant level and no additional investment was made for reduction of energy conservation. Reasonable economy measures were taken for energy saving/conservation. No comment is made on technology absorption considering the nature of activities of the Club. There has been no foreign exchange earning or outgo during the year.

26. **Statutory Auditors**


Messrs. H. Naik & Co. Chartered Accountants, the Statutory Auditors of the Club retire at the ensuing Annual General Meeting and are eligible for re-appointment.
